

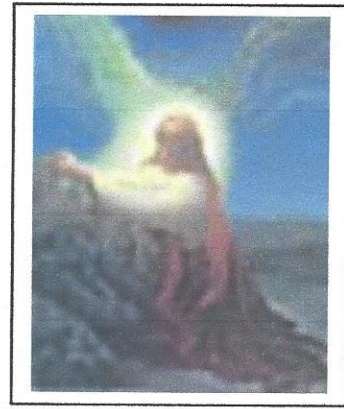

ARCHAEOLOGY AND CITIZENS OF THE STATE OF FLORIDA**

**SUBJECT: RELIGIOUS CANON VS. STATE LAW ... WHO IS THE GUARDIAN OF  
HOLY RELICS? ARE THEY IN CAPTIVITY?**

It is well settled that the State of Florida Statutes project the sovereign submerged ocean properties and all that is contained therein, i.e., shipwrecks, cargo, and archaeological artifacts. Florida Statute Section 267 and the U.S. Shipwreck Act of jurisdictional rights and admiralty claims of their ownership. The purpose of the law being protective action to public domain issues and ownership when citizen concern if for preservation of historical cultural archaeological properties.

At issue: In salvage agreements governed by secular law, there is no mention or concern for religious historically significant artifacts, consecrated holy relics, or Conquistador human remains. Documented Spanish history, Archives of the West Indies, and Museum of the Americas in Madrid authenticate, always name and describe their vessels and their cargo manifests. The Kingdom of Spain and its sovereign ruler throughout history is always referred to as His Catholic Majesty and King. Secular law makes no provision or protection for holy relics, military human remains, or historical religious significant artifacts. Regardless of numismatic or monetary value, why does the State retain ownership to intrinsic recovered artifacts on the premise of "one of a kind" to be held captive forever in a secular museum?

Do not these secular laws violate the First Amendment of the U.S. Constitution as paraphrased: "The free exercise of Religious rites and practices." How you may ask? In voluminous court records and State of Florida Department of Archaeological records, there is specific mention of a significant religious artifact in State of Florida submerged ocean waters: THE GOLDEN LIFESIZE MADONNA AND CHRIST STATUE, the attempt to recover it to complete the Christian ceremonial religious act of ecumenism.

Continuous on-going requests by secular law and procedure to satisfy State Statutes were conducted by Metropolitan Archbishop +Haralambos of the Christian Eastern Orthodox and Catholic faiths, to free the captivity of this holy relic. Numerous documents are of record to the State that this pursuit was sanctioned and blessed by the Vatican Pope John Paul II and the Kingdom of Spain, King Juan Carlos I. The proven existence of this artifact has been authenticated by the Kingdom of Spain, Ministry of Culture and recorded Canon law of the Holy Catholic Church. The State denies, or at least questions, that this holy relic even exists. The State ignores and has stonewalled any attempt for recovery. Why does it claim its right to RESERVE the precise area where the Madonna and Christ Child golden statue lies buried off Jupiter, Florida?

DOCUMENTED LAW:

- Religious freedom – F.S. 2007, Chapter 761, titled Religious Freedom. F.S. 761.05 labeled Applicability 1-7, supports this claim of the ecclesiastical and authorship under definition F.S. 761.02.
- F.S. 761.02 defines under the Religious Freedom Law exercise of religion means “an act or refusal to act that is substantially motivated by a religious belief, whether or not religious exercise is compulsory or central to a larger system of belief.”
- F.S. 761.03 states free exercise of religion protects above which clearly conflicts with F.S. 267, since it interferes in the Religious Freedom of a creditable religious institution of State record and its pursuit and possession of the Golden Madonna and Christ Child statue. This holy relic is a religious sacramental artifact to the traditional Christian Church. The statue was created in the 1650s by the Kingdom of Spain and was en route to the Vatican. The ceremonial purpose was to prevent Christian disunity in the Spanish Catholic empire, recognizing the Vatican and Pope Innocent X as its hierarchal religious authority protected by Catholic King Philip IV of Spain.
- Chapter 872, F.S. 2007 labels Offences Concerning Dead Bodies and Graves has in 872.05 Unmarked Human Burials, subheading 2, labeled Definitions; identifies the State Archaeologist and his due diligence in these matters, Section 4b puts a time frame of 75 years or more on human remains.
- F.S. 267 definitions of procedures in archaeological excavation of shipwreck salvage contracts conflict and fail to address or respect holy relics prepared for ceremonial ritual, military conquistador bones, nor support by stated law any definition as to legal ownership by the religious entity.

RELIEF is sought as an ecclesiastical authority, in three areas at issue, by executive and legislative support:

- a. We seek executive and legislative support whenever holy relics are retrieved, specifically, human remains of known Christian military from shipwreck sites as to law for procedure and provision of proper burial ceremonial rites on consecrated ground.
- b. We seek documented and written stated law by a gubernatorial and legislative forum to prevent the foreclosure of ownership by others, whenever recovered, under F.S. 267 State law over-site, specifically, the holy relic: The Golden Madonna and Christ Child statue, whose rightful ownership is the Christian Eastern Orthodox and Catholic Churches.
- c. Removal of the term “reserve” by past State executive orders from the Jupiter/Juno areas, pertaining to ocean shipwreck sites, whereby removing the captivity of holy relics.

## Holy Relics

Holy Relic, *def. an object esteemed and venerated because of an association with a saint or martyr.*

Holy Relics have been a part of the history of man since the beginning - from martyrs' coffins that ooze myrrh to martyrs who do not corrupt after many years in the grave and Icons that flow with tears. Mankind has taken notice of these unique events and has tried to preserve the Holy Relics as they have manifested to them. In the Eastern Orthodox Church, holy relics are sewn into the altar cloths that lay on the Holy Table and then are used for the sacramental rituals such as Holy Communion. In the 7<sup>th</sup> Ecumenical Council, Canon 7 dictates, that an altar without the Holy Relics be torn down. It brings to mind the early church having a worship service in the catacombs celebrating over the bones of a saint or martyr.

In the Catholic Church, the Canons are also quite clear when it pertains to Holy Relics. As an example, Canon 1190 §1: It is absolutely wrong to sell sacred relics. Canon 1190 §2 states: Distinguished relics, and others which are held in great veneration by the people, may not validly be in any way alienated nor transferred on a permanent basis, without the permission of the Apostolic See.

Holy Relics not only apply to the bones of martyrs and saints, but to objects that honor them. In the Old Testament, Elijah cast down his mantle to Elisha. Elisha used the mantle to strike the Jordan and part the waters so he could cross over. The mantle became a Holy Relic.

We read in the New Testament of St. Paul that when his handkerchief touched people who were sick, they were healed. Even the shadow of St. Peter casting on the sick healed them. Probably the most profound Holy Relic was the Mandylion, a cloth that Jesus wiped His face into and imparted His image into the cloth. This is known as the Icon not painted with human hands. The cloth was taken to the King at Edessa and, gazing upon the image of our Lord, the king was healed.

There are so many other stories to recount regarding Holy Relics, but one is before us today in the 21<sup>st</sup> century. A Life Size Solid Gold Madonna and Christ Child Statue that was commissioned by King Philip IV and cast in the Potosi Mines of Peru. This Holy Relic depicting the most precious event, the Savior of the world being held in His mother's loving arms. This Holy Relic blessed and sanctified by priests, was loaded aboard the Kings flag ship, the Nuestra Señora de las Maravillas and was destined for Catholic Spain, there to be given as a gift to the Pope of Rome, Pope Innocent X. The ship wrecked off the coast of the Bahamas but it was salvaged by Spain and the Golden Statue was loaded aboard the Spanish Galleon, San Miguel Archangel. This ship also wrecked off the coast of Jupiter, Florida, where it rests today.

My prayer is this, "When the golden statue is recovered from her watery vault, it will finally complete the intended trip to Spain, then on to the Vatican as it was planned by the King of Spain. Father John Bosco had a vision of this very event. May it come to pass in our generation.

## **What is Simony?**

Simony is the deliberate intention and act of selling and/or buying spiritual goods or material things so connected with the spiritual that they cannot be separated from it. Simony is a violation of the virtue of religion, and a sacrilege, because it wrongfully puts a material price on spiritual things, which can be neither bought nor sold. The term is derived from the name Simon Magus who, in The Acts of the Apostles, tried to buy the power to confirm people in the Holy Spirit.

## **Where can Simony be found today?**

Simony can be easily found in today's antique stores and internet auction sites. Sellers state they are selling the theca (metal container that holds the relic) and the actual relic is a gift to the highest bidder. While some theca's and reliquaries are very ornate and expensive most are crafted from nonexpensive metals that range in price from 5 to 10 dollars. Yet one may search an auction site and find these same theca's in the price range of 50 to 300 hundred dollars. One auction site in particular claims their policy does not allow human body parts (including bone) to be auctioned on their website. They also state that these illegal items can in no way be attached (as a gift) to the actual item being auctioned. When Guardians of Holy Relics witnessed what was taking place we notified the auction site and was told they were not skilled in Roman Catholicism and they did not know exactly what it was that was being sold. Never the less simony is running rampant today as it has in the past. Guardians of Holy Relics has saved a few of these holy relics by contacting the seller and also the internet auction site. As of today Guardians of Holy Relics has shut down many auctions of holy relics as well.

## **Canon Law**

Can. 1186 : To foster the sanctification of the people of God, the Church commends to the special and filial veneration of Christ's faithful the Blessed Mary ever-Virgin, the Mother of God, whom Christ constituted the Mother of all. The Church also promotes the true and authentic cult of the other Saints, by whose example the faithful are edified and by whose intercession they are supported.

Can. 1187 : Only those servants of God may be venerated by public cult who have been numbered by ecclesiastical authority among the Saints or the Blessed.

Can. 1188 : The practice of exposing sacred images in churches for the veneration of the faithful is to be retained. However, these images are to be displayed in moderate numbers and in suitable fashion, so that the christian people are not disturbed, nor is occasion given for less than appropriate devotion.

Can. 1190 §1 : It is absolutely wrong to sell sacred relics.

§2 Distinguished relics, and others which are held in great veneration by the people, may not validly be in any way alienated, nor transferred on a permanent basis, without the permission of the Apostolic See.
